Corporate member \$500 (under 50 employees) \$1,000 (more than 50 employees)
Any partnership or organization controlled by a majority of registered Cree beneficiaries engaged in arts and crafts activities within the traditional territory of Eeyou Istchee is eligible to be a Corporate member. Corporate members shall participate in the activities of the Corporation. They do not have a right to vote at member meetings. They are not eligible to be elected or appointed as a director of the corporation.

Honorary member (Selected by the CNACA Board of Directors)
Any elders, individuals or organization which has rendered exemplary service to the Corporation or to the arts and crafts in Eeyou Istchee is eligible to be an honorary member. Honorary members are selected on an annual basis by the Board of Directors of CNACA. Honorary members shall participate in the activities of the Corporation. They do not have a right to vote at member meetings. They are not eligible to be elected or appointed as a director of the corporation, unless they are Cree beneficiaries under the James Bay Northern Quebec Agreement (JBNQA).
